GASPARAVICH FUND balance: \$6514.18

MARIE HUSEBY CULTURAL EVENT FUND balance: \$8, 870.43 after withdrawing \$1,000.00 to transfer to the Operating Funds to cover the King County Breakfast.

We have lost about \$1200 in Huseby Fund since November due to stock market declines.
